Chadd Smith Joins Ridgefield NWR Staff

Chadd joined the Ridgefield National Wildlife Refuge (NWR) staff last November as an Engineering Equipment Operator. He comes here from the Kilauea Point NWR on the Hawaiian Island of Kauai.

Chadd has been working with the **U,S. Fish & Wildlife Service (USFWS)** for 21 years — 19 as a full-time employee. He brings extensive knowledge and experience in designing and building wetlands to enhance them for waterfowl. He received the **Pacific Region "Recovery Champion Award"** in 2014 recognizing his efforts to effectively manage wetlands for endangered **Hawaiian** waterfowl.

Chadd spent part of his early years in the **Ridgefield** area. He hunted the refuge with his dad and brother. He is an avid upland bird hunter and enjoys hunting with his two (2) German Shorthair Pointers. He is also a seasoned waterfowler. We are thankful to have him here at **Ridgefield NWR** and look forward to his work with wetlands here. **Chadd** quickly got to work and installed the **Black Box Pit Blind** — one of two (2) previously purchased by our chapter a couple of years ago.

Black Box Pit Blind Installed!

On Monday, August 1st, **Rich Hannan** and myself met with **Chadd** to scope out what can be done with the remaining time before flood up on the refuge. **Chadd** committed to creating a temporary trail to blind 9 with the idea of a permanent trail repair next summer. He agreed that replacement of blind 6 was doable under the conditions and surprised us with, *"How about Thursday?"* Rich and I returned Thursday morning and assisted with the installation.


Chadd deftly removed the existing two-man pit filled with nasty water and dozens of live and deceased garter snakes. Next he pulled the oneman cylinder. As a veteran of many blind clean ups, I will not miss those old cement pits! The **Black Box Pit Blinds** are constructed of an advanced **polymer-blend** that are lite weight and guaranteed for life never to rust or corrode. Unfortunately the manufacturer went out of business in 2018. Ours were constructed for four (4) hunters, but we have converted one of the end slots in each for a dog box.

Chadd carefully dug out the hole for the new **Black Box Pit Blind.** We were able to build the anchor system out of 4x4 and 2x6 treated lumber on site at the refuge. **Chadd** layered the bottom of the hole with gravel and lowered the blind into its new home. He added a large "blow down" tree branch to facilitate natural cover on the backside.

The following Thursday we were able to rough up and camo paint this blind and drop in the blind chairs, and it's ready for the season. The remaining **BB** blind still in reserve will be installed next summer. Hats off to **Chadd's** willingness to get on this project quickly and carefully preserving the cover around the blind.

Ridgefield NWR Work Party on August 16th

As this Newsletter goes to publication, we will have a work party to paint the other **BlackBox Pit Blind** to be installed next summer. We will also prepare the flatbottom boats provided very reasonably to the chapter **by Jerry Piazza** for blinds #16 and #5. (Continued on Page 7)

New RNWR Lottery Application Process

The **Ridgefield NWR** announced they are implementing the **"Direct Access" Lottery** for hunting this season. Application is online with a \$5 fee and \$1 per pick. This has been a popular system used by other refuges. It will dramatically streamline the process and allow hunters to be notified within a week or so of the end of the application period, August 15th – September 23rd.

Grant Application Unsuccessful

As mentioned last month our chapter had applied for a **Covid Relief Grant** being distributed by **Clark County** to small businesses, nonprofits and community serving organizations. The grants are part of a state and local economy recovery program funding included in the **American Rescue Plan Act (ARPA) of 2021** to help with the negative monetary effects of **Covid-19**.

The following Tuesday, August 23rd [Note the New Date], the Chapter will be holding its Quarterly meeting beginning at 6 pm at the O'Sullivan Sportsman Resort Clubhouse (near Potholes State Park — 6897 Hwy 262 SE, Othello, WA 99344 for *GPS* purposes).

The meeting will feature a presentation by Marc Maynard, the Ephrata Field Office Manager for the Bureau of Reclamation. Marc manages the water systems of the Columbia River as well as all the reservoirs and canals in the Columbia Basin.

Flat Lake Acquisition

The **WDFW Commission** just authorized the **Department** to go forward with the purchase of two (2) private inholdings on **Flat Lake**, just south of **George**, **WA**. **Flat Lake** is a seep pond that is literally a "duck factory" in the spring and has good waterfowl harvesting opportunities during the hunt season until the irrigation canal is drained.

This purchase was came as a result of the 2021-2022 **Migratory Bird Stamp and Print Fund** expenditures authorized by the **WDFW's** citizen **Waterfowl Advisory Group (WAG)** in 2020.

Gretchen Fitzgerald, a retired WDFW biologist and Dick Price met with the property owner, Woody Trihey, in 2019 as he had expressed a desire to sell the property to WDFW for fair market value. From there Dick worked with Sean Dougherty in the WDFW Ephrata Office to put together a proposal for the purchase of the property. This was presented to the WAG in 2020 for the 2020-2021 budget approval and was unanimously supported by the WAG members. Currently WWA has four (4) members and five (5) former WWA members on the WAG.

This is another example of what your "Duck" Stamp funds are used for.

Area WDFW Summer Banding Projects

WDFW staff has busy with duck and dove banding projects in the area over the course of the summer. The **Department** has already banded some 200 ducks toward a

goal of 1,000 ducks, and are nearly at their goal 600 doves. (See **WDFW News** on **Page 21**).

Primarily they have been banding mallards but occasionally some red heads and pintails show up in the mix. Trapping and banding ducks will continue until just before the waterfowl hunt season in early October.

Good luck with that as all hunters find it extra special when they can harvest a banded bird. One can often call in the data while still the field!


Glen, after 4 and a half hours in the water made it to shore — waders and life jacket on.

WA Waterfowl Association, Yesterday and Today

Yesterday:

The Washington Waterfowl Associa n (WWA) was founded in 1945 as the "Washington Duck Hunters Incorporated (WDHI)." The founders were convinced that "Only through the united efforts of its members would the voice of the wildfowler be heard." The organization's goals were:

- 1. To conserve our waterfowl and preserve and improve our hunting opportunities, and
- 2. To secure more hunting areas from state and federal agencies.

This newsletter declared, even in 1945, that more resting and feeding areas were needed to hold birds in our state and to aid them during migration. The newsletter ended with the plea to **Washington** waterfowl hunters, "The organization needs you as much as you need them. They're your ducks, and it's your duck hunting, protect them both!"

The 12 founding members of WDHI all owned or were part of a group that had "Duck Shacks" on the North Fork of the Skagit River along Fir Island. Their concern was that ducks did not stay in the area very long, so in 1954 they convinced U.S. Senators Warren Magnuson and Henry "Scoop" Jackson to pressure the Washington Legislature to spend Pi man-Robertson funds to buy Fir Island for thethen Washington Department of Game (WDG) as a resting and food source for migrating ducks.



This was the first of several attempts by **WDHI** to increase harvest potential. The second attempt was they paid **WDG** to trap mallards in the **Columbia Basin** and transport them to the **Skagit Flats. WDG** trapped 50 pair and released them on the **Big Ditch** area. The ducks were back in the **Basin** before the **Department** employees returned home. lol

The Beginning of Funding for WWA

WDHI has had many homes over the years, when Dick Price first joined in 1960 we were meeting at the Paine Field Gun Club in Evere ;

The first newsletter of the newly formed **WDHI** stated that the organization had one objective: "To do everything possible to provide more and better duck and goose hunting for hunters of the Northwest." This newsletter also pledged that the organization would, "Keep in touch with activities of both the-then **Washington Department of Game (WDG)** and the **U.S. Fish and Wildlife Service (USFWS)** and try to protect our rights as hunters." The newsletter noted that, "We are the only group in the state devoting all its efforts to obtaining better waterfowl shooting." Additionally added was the statement, "We are exerting every effort to establish duck refuges in **Washington,** and wherever possible, to have public shooting grounds in conjunction therewith."

then the Sea le Gun Club in Redmond; then back to Paine Field. From there one of the founders, Ferd Nist, bought the Clearview Gun Club, and WDHI met there for many years until Ferd's death. As part of the original deal, every time WDHI had \$1,000 in the bank, Ferd would sell it a share of the Gun Club.

At **Ferd's** passing **WDHI** was able to continue operations for another year or two before **Ferd's widow**, **Ione**, gave us an ultimatum — either buy the **Gun Club** or she would sell it. We were not in a position to buy it nor run it so it was sold, and **WDHI** received our share of the proceeds from the sale which became the seed money, the bulk of which **WWA** still has.

The Beginning of the WA Migratory Bird Stamp

In 1984 WDG Director Jack Whalin, convinced John Scott and Dick Price that we should approach the Senate Natural Resources Chairman to draft a bill for a State Duck Stamp to create and maintain a separate fund dedicated for strictly for waterfowl projects. As John and Dick were co-chairs of the WA State Sportsman's Council we drafted a resolution to do just that and got approval of the entire State Wildlife Committee.

So in 1984 Dick Price, John Scott, Robert Hood Hickok, then-WA State Ducks Unlimited (DU) Chairman Johnny Walker, and the paid lobbyist for the Wildlife Committee all met in the office of the Senate Natural Resources Committee Chairman. After he looked at our draft bill, he said no way would he consider our bill.

However he said he would have one of his people rewrite the bill, and if we would approve it, he would move it forward. Frankly he didn't think hunters could get the support of other hunters to "tax" themselves beyond the existing federal duck stamp. In 1986 the bill became law, and the **Washington Migratory Bird Stamp Program** was created and has generated a lot of money for multiple waterfowl projects around the state.

Today:

WWA has strayed little from the original goals set in 1945. We still focus entirely on our state and do everything possible to preserve our waterfowling heritage. We pride ourselves in being the voice of the Washington waterfowler and every dollar we receive stays in our state.

As explained on our website linked <u>here</u>, we are focused on **Conservation**, **Hunter Advocacy**, **Access**, **Education**, and providing a **Community** where Washingtonians interested in waterfowl and waterfowl hunting can interact together.

<u>Conservation</u>: Our motto is "Hunters for Conservation," and this is the work we most enjoy. Our habitat improvement efforts include spraying and removal of invasive plants, installing and maintaining wood duck boxes, mallard nesting tubes, and goose nesting platforms. In addition our "Hands-On Conservation" includes volunteer work on bird banding projects with the Washington Department of Fish and Wildlife (WDFW); performing waterfowl population counts for the USFWS; planting crops vital for waterfowl during both the fall and spring migration. Many of our members serve on the state's Waterfowl Advisory Group (WAG) to provide advice

to the WDFW regarding hunting regulations, and bag limits, and directions for expenditure[s] from the dedicated fund established by the Washington Migratory Bird Stamp Program. Since 2012 WWA has also run the Washington State Duck Stamp and Print Program, linked here, which garners more conservation funds and supports the Junior Duck Stamp Program, which encourages young artists.

<u>Community</u>: Our dedicated members are what make WWA "tick." We are a "boots on the ground" organization with much to offer for those who love the waterfowl and wildlife heritage with which we are blessed, and who are willing to "give back" to these resources so they may be enjoyed by future generations.

We have chapters all up and down the I-5 corridor from Vancouver, Gray's Harbor, Tacoma, Seattle, the Skagit Area, to Whatcom County; and across the Cascades in Spokane, Moses Lake, Wenatchee and the Yakima Valley. We are actively seeking to add to this list!

WWA Yesterday & Today Continued

Our chapters provide monthly meetings and other social events where our members may gather, often shoot trap or 5-stand, swap hunting stories, and generally enjoy each other's company. Besides the **website**, we also maintain **Facebook** and **Instagram** accounts for those who enjoy waterfowl.

<u>Hunter Advocacy</u>: As in 1945, we are still the only waterfowl hunter advocacy group focused exclusively on Washington State. In recent years we've found ourselves fighting to preserve and protect areas where waterfowl hunting has historically been allowed. Recent victories include defeating a proposed **Thurston County** ordinance which would have effectively closed hunting to much of **southern Puget Sound**.

We succeeded in getting the **Bonneville Power** Administration (BPA) to withdraw a plan to drain Shillapoo, a large state-run Wildlife Management Area (WMA) in southwest Washington. Had this plan gone to completion, it would have reduced Shillapoo waterfowl usage by twothirds and hunter area by one-third.

We also stopped a plan to connect **Post Office Lake** on the **Ridgefield National Wildlife Refuge (NWR)** to the **Columbia River**. This would have introduced carp and other invasive plants into the lake and destroyed a habitat frequently used by Canvasback ducks.

Our most recent victory — in which we received a lot of help from various tribes — involved shelving a proposed **Whatcom County** ordinance to ban hunting in **Drayton Harbor**, a great place to hunt sea-ducks.

Unfortunately, we have also suffered some defeats. We couldn't stop an action — greatly deleterious to Waterfowl — on the Farmed Island segment of the Skagit Wildlife Area in north Puget Sound.

We have been trying for years to limit or stop indiscriminate eelgrass spaying in **Pacific County's Willapa Bay**. Eelgrass is essential to the **Black Brant** and many other waterfowl and is also important as nesting cover for forage fish vital to salmon, such as herring. There's strength in numbers and, as in 1945, we could use more numbers!

Access: We maintain blinds and access trails in many WMA's as well as the Ridgefield NWR and in more local places as well. We have purchased and built numerous blinds including several intended for those with limited mobility. Our chapters re-camo these blinds in the early fall and clean them up after season's end.

Education: We have an active hunter mentorship program focused on introducing waterfowl hunting to those who have never tried it, and we also partner with other organizations in holding various "wounded warrior" hunting events for disabled veterans.

We are in the process of completing a "Waterfowl 101" course to be displayed on our website.

We hold the official **Washington State Duck and Goose Calling Championship** every year — the winner of which goes to Stuttgart, Arkansas, to compete in the **World's Championship Duck Calling Contest**, and we sponsor a **junior calling contest** to encourage youth.

We also count among our membership quite a few **Hunter Ed instructors**.

Over the years **WDHI/WWA** has made a lot of progress on habitat projects and made sure that the *Voice of the Waterfowler* has been heard. Unfortunately over the past several years our voice on the West Side has been overshadowed by that of the Federal Government and their ability to throw money at **Salmon Recovery** without much success, but the loss of several prominent waterfowl hunting, feeding and resting sites.

We love the natural bounty found in our state and wish to preserve, protect, and enjoy it!

WA Legislative Report

Did You Do Your Duty?

"The price of freedom is eternal vigilance." -- Thomas Jefferson

The Washington State Primary is over. In the April 2022 *Legislative Report*, I urged Washington hunters to get involved in state politics. Hunters Heritage Council Hall of Fame Member Brian Blake asked, "Hunters have one chance. Will they get out on the ground and work for pro-hunting/conservation candidates from August through the election?" From the election analysis, sportsmen and sportswomen unfortunately voted in very low numbers and also unfortunately answered Blake's question with a resounding "NO!"

If you didn't know who to vote for the **WWA** gave you the **HHC's** endorsement as recommendations. The **HHC** fully vets and researches its endorsements to make sure that they are endorsing the best candidates for the hunting community.

There was no reason for not voting. If you didn't like the **HHC** endorsements, then vote your own ticket, but vote. **Blake** implored, *"Hunters/conservationists need to work for the future of our heritage or not. It is their call."* This starts by voting. This is not a guilt trip. This is asking to take a hard look in the mirror. We have seven (7) short weeks until the general election, and we need a more friendly **Senate Natural Resources Committee.**

One really bright spot for the hunting community, especially the waterfowl hunting community, our public enemy number one, **Alicia Rule** only received 48.68% of the vote, and the two Republicans combined received 51.26% of the vote, with the **HHC-endorsed** candidate, **Tawsha Dykstra Thompson** receiving the vast majority of the Republican vote at 35.24%.

If you remember, while serving on the **Blaine City Council, Alicia Rule** was the prime sponsor of the **Drayton Harbor No-Shooting Ordinance.** We need to work for Tawsha — help her even if you're not in her district. *"The entire house is up this year and half the Senate,"* notes **Brian Blake.** *"Every seat matters."*

Blake foresees another wave election building this fall and advises sportsmen to harness it. *"Hunters should be door-belling for candidates and marching in parades with candidates. Work to elect legislators who can stop the anti-hunting agenda," he says.*

I beat this drum before, and I will beat it again. I will sound like a broken record. Do you care enough about our sport to fight for it? Hunters need to get involved with electioneering. We all need to get involved this fall and work for pro-hunting candidates. Listen to **Brian Blake!** *"Elections and hunting season happen simultaneously and hunters need to participate in both if we are to retain our heritage."*

A Democrat and multi-year **HHC Legislator of the Year**, **Blake** was a backstop in **Olympia** on hunting as well as gun laws (he's an **NRA Life Endowment Member**). *"Majorities matter*, *I am no longer there to protect our Heritage."* Help our **HHC-endorsed** candidates like **Tawsha Thompson.** We can defeat **Alicia Rule!** Majorities matter! Whether you doorbell for them, make phone calls for them, send them a contribution — help them in some way.

I have repeated **the three "T"**s a candidates needs to win a campaign, and I will repeat them again; "Time," "Talent," and "Treasure." Pro-hunting candidates need volunteer hours to put up signs, doorbell, and other tasks, they need your **"Time," the first "T."** If you are an outstanding graphic artist, have special press skills, or are have outstanding fundraising skills, pro-hunting candidates can use your **"Talent," the second "T."** Finally, pro-hunting candidates need money — a lot of it — to win their races. They need your **"Treasure," the third "T."** As **Brian Blake** said, every seat matters and this should be a wave election.

We have a very, very bad **Fish and Wildlife Commission.** We all have to do our part. Not everyone has the finances to contribute to a campaign. The one thing everyone can do is **VOTE.** You have no excuse for not voting. If you can commit to a campaign, do it. Our hunting future depends on all of us.



Beginning around July 1st, WDFW staff and volunteers have been capturing and banding Mourning Doves as part of our effort to monitor harvest and survival of this migratory game bird, — who along with **Band-Tailed** Pigeons — usually receive about five per cent (5%) of "Duck Stamp" monies in Washington State.

Most mourning dove are captured using a simple walk-in trap baited with wheat grain. Birds are aged as Hatch Year (HY) where sexing is not determinable by plumage, or After Hatch Year (AHY) where sex determination is easier but not always possible.

We actively trap in multiple areas, mostly on the east side of the state, but we have some banding occurring

California Raises Cost of Duck / **Upland Stamps for Nest Habitat**

JOINT NEWS RELEASE: **California Waterfowl Association**

State legislation to incentivize the creation of upland nesting habitat for ducks and other ground-nesting game birds in California will result in a \$10 surcharge on the price of both the California Duck Validation and the Upland Game Bird Validation next hunting season.

For the 2022-23 hunting license year, the cost of the California Duck Validation will increase to \$34.56 (\$23.25 in 2021-22).

The Upland Game Bird Validation will cost \$21.60 (\$10.54 in 2021-22).

The bird hunting validations, along with 2022-23 hunting licenses, tags and related items, were made available for purchase beginning April 15th. The \$10 surcharge is added to the annual price increase mandated by state law (\$1.31 for the California Duck Validation and \$1.06 for the Upland Game Bird Validation).

The legislation requiring the \$10 surcharge for each validation does not apply to validations included with the Lifetime Bird Hunting Privilege Package purchased by Lifetime Hunting License holders.

AB 614 by Assemblymember Cecilia Aguiar-Curry (D -Winters) was sponsored by the California Waterfowl Association (CWA) and signed into law by Gov. Gavin Newsom last October.

The resulting \$10 surcharge is expected to generate more than \$2 million annually to fund the Nesting Bird Habitat Incentive Program, which will be administered by the California Department of Fish and Wildlife (CDFW) to benefit nesting mallards and other puddle ducks, wild ringnecked pheasants, pollinators and other grasslanddependent species.

All revenue generated from the validation surcharge must be dedicated to the program by law and cannot be diverted to other uses.

"I am proud that **CWA** sponsored this important legislation, and I am excited to see it implemented on the ground," said CWA President John Carlson Jr. "Once again, hunters are taking the financial lead to ensure that our

nesting bird populations have the habitat necessary to be successful."

The Nesting Bird Habitat Incentive Program is California Department of Fish and Wildlife designed to provide financial incentives to California landowners to cultivate or retain upland cover and other vegetation to benefit nesting wildlife. The funding can also be used to support habitat work on state wildlife areas and national wildlife refuges open to public hunting.

> As a result of drought and water shortages, thousands of acres rice fields and other farmland throughout the state were fallowed last year. The **Nesting** Bird Habitat Incentive Program will soon be able to offer those farmers financial payments to plant their fallowed fields in cover crops and other beneficial vegetation to provide productive nesting habitat for ducks, pheasants and other wildlife.

Potholes Reservoir Water Access Area to Close thru mid-December

SPOKANE – The popular **WDFW-managed Glen** Williams Access Area on the Potholes Reservoir in Grant County will close for construction from August 15th until December 15, 2022.

People from all over the state come to Glen Williams to launch boats and take advantage of great fishing and water recreation opportunities. The ramp is in poor condition and improvements are necessary to keep it safe and usable for the public. Work on this project will include installing a new boat ramp and ADA (Americans with Disabilities Act) loading area and paving and striping the ADA and launch area. This work is happening now to take advantage of low water levels. New toilets and a board float will be installed at a later time when materials become available.

For those who use the **Potholes Reservoir**, there are alternative launch areas nearby including at MarDon Resort, Potholes State Park and at the nearby WDFWmanaged Blythe Water Access Area. MarDon and the State Park launch are accessible at low water.

Update on Whatcom County Black Bear Attack

Updated Aug. 10, 2022 WDFW News Release

On Wednesday, August 3rd at about 8:30 a.m., **WDFW** Officers received a report of a human-black bear incident that occurred on a trail in a forested area north of **Lake Whatcom in central Whatcom County.** The person involved is an adult male who was jogging on a trail. He sustained multiple injuries to his hands and feet and received medical care at a local hospital.

"We are extremely thankful that the victim is recovering and receiving medical care from this unfortunate encounter," said **Captain Jennifer Maurstad, WDFW Police North Puget Sound**. "He did everything right during the incident and we wish him a speedy recovery. Wild animal encounters are unpredictable but, in most cases, they wish to avoid conflict as much as we do."

The victim was released from the hospital later that afternoon. That evening, officers with the use of a **Karelian** bear dog located and lethally removed an adult black bear near where the incident occurred.

In Washington state, the only recorded fatal black bear attack on a human was reported in 1974. Since 1970, state authorities have recorded 18 other human-black bear encounters that resulted in a documented injury. The most recent was in 2015.

Advice if You Contact a Bear in the Wild

WDFW officials offer the following advice to minimize the risk of injury if a bear is encountered in the wild:

In general bears avoid people, but they're naturally curious animals. If a bear walks toward you:

- Identify yourself as a human by standing up, waving your hands above your head, and talking in a low voice.
- Back away, avoiding direct eye contact.
- Don't run from a bear.
- WDFW recommends making noise and leashing pets while hiking.
- Be aware of your surroundings as to not accidentally startle a bear.
- While recreating, WDFW recommends carrying bear spray that is readily accessible and knowing how to use it. More information on how to use bear spray is available on WDFW's blog.

State law requires **WDFW** to post on its website all reported incidents involving "predatory wildlife," **defined as cougars, wolves, and grizzly bears.** As directed by **RCW 77.12.885** linked <u>here</u> this includes accounts of "safety confrontations or sightings, as well as the known details of reported depredations by predatory wildlife on humans, pets, or livestock" within 10 days of receiving a report.

WDFW bases this information on reports by citizens to the **Department**. Multiple reports that are very close in time and geographic location may be recorded as one incident. All reports are sited in the general vicinity of the incident.




